"This course serves as the "dissertation" for our doctoral degree, which is typically completed by students during the 4thyear of the program. On occasion, students are unable to complete this course during their 4th year of the program. Students then leave campus for a year-long internship. The IP credits for PSY 990 then turn into NC. We are requesting that IP grades for PSY 990 use the policy for IP credits related to Thesis, which must be changed within 7 years. This will reduce paperwork and administrative load for the Registrar."
