

- Dr. Baggett began a discussion on the Graduate Council
 Handbook. The Handbook was revised four years ago and the
 version is designed to more accurately reflect the operations of
 the EKU Graduate Council. Members of the Graduate Council
 are encouraged to review the document prior to the next Graduate Council meeting on Friday,
 23 October 2020. Feedback may be sent to Dr. Sabin or Dr. Baggett.
- Dr. Pogatshnik provided a historical perspective on the document from 10 − 12 years ago. He noted that there were four committees (included a quality enhancement committee that was developed after a SACSCOC review). However, there was really no mission for the committee and it had no real tasks after a while. The Student Affairs committee was designed to hear student appeals on various issues, tasks that were later moved to the Graduate School office based on the vote of a Graduate Council. It then changed to help with outstanding thesis, scholar's week and now will be running the Three Minute Thesis (3MT) project for EKU.

Note, Dr. Oakley was notified during the meeting that the existing 3MT information on hand was moved to the Graduate Council website for his (and his subcommittee's review).

- Dr. Pogatshnik noted that an evaluation of the number of council members, subcommittee tasks, roles and responsibilities and well as other council operations could be analyzed as part of this handbook revision.
- Dr. Sabin concluded this month's discussion of the handbook by noting that he would like to implement the handbook through a formal vote at an upcoming meeting. If a substantial amount of feedback is obtained prior to the October meeting, we will use it as another "good of the order" discussion point. If not, it will be placed on the agenda as an actionable item.

- Dr. Pogatshnik provided a historical perspective on the policy review process at EKU. Retired Associate Provost Sherry Robinson was in charge of EKU Policy reviews until her retirement. At that time, the responsibility was given to the EKU Legal Office and Mrs. Haley Norberg is now directing policy review efforts. In the past, the Graduate Council has been responsible for their own policies with the Graduate Council serving as the drafting team. The policy was then sent to the EKU Council on Academic Affairs for review/approval.
- Dr. Pogatshnik also provided context on EKU Policies, which are separated by Volume.

 - O Volume Four (4) is the volume for Academic Affairs
 - Specifically, chapter five within volume four contains four specific policies on graduate education:
 - 4.5.2 Time Limit on Graduate Degree Programs
 - 4.5.3 Academic Bankruptcy of Graduate Work
 - 4.5.4 Midterm Grades for Graduate Courses
 - 4.5.5 Limits on Transferred Graduate Work
 - While there are other policies that impact graduate education, these four were developed by the Graduate Council.
- The question now becomes...who owns the revision process?
- Likely two primary options:
 - 1) EKU Legal Counsel Office forms a drafting team who reviews all policies (to include graduate education policies. Graduate education related policies would require a Graduate Council representative on the drafting team. The results of that drafting team is then sent to the Graduate Council for review. (*University-Driven Approach*)

- 2) Maintain the existing structure that whenever a 4.5.X policy (see list above) is due for review, the EKU Graduate Council serves as the drafting team. On all other policies that affect graduate education, the Graduate Council provides a representative on the drafting team. Dr. Sabin noted that this process could also include outside graduate faculty on the drafting team if necessary. (*Graduate School Driven Approach*).
- Dr. Pogatshnik noted that regarding policy, it should be the graduate council's responsibility to ensure that EKU policy conform to best practices of graduate education. Additionally, after the 23 October 2020 Graduate Council meeting, he will need a recommendation to take forward to the policy group.
- Dr. Richardson asked about delaying the policy development process with option one which would likely take longer than option two.
- Dr. Sabin requested the use of **polling the Graduate Council members after they had time to consider both options and discuss with their EKU colleagues**. See information in action item box regarding the polling plan.



Curriculum Changes for the September 18, 2020 Meeting

Good Afternoon Sherry and Faye,

The Executive Committee of the Graduate Council met earlier today to discuss the agenda items for the 18 September 2020 meeting. As you may know, each subcommittee chair provides initial feedback to the Executive Committee on the agenda items. This email concerns the COE curriculum changes that were submitted for the 18 SEP 2020 agenda:

1) Please note that the Graduate Council cannot include the EME 378 – Teaching Music in Grades P-8 course in their review due to the undergraduate level of the course. Please submit that course (and any other undergraduate courses) directly to CAA.

COE RESPONSE: *Dr. Nicola Mason (Interim Chair)*: Apologies for the oversight. Thank you for the correction

2) Regarding the two course drops of (EME 579/779 – Music Education: Principles and Practices), the council would like to know what courses will be replacing those two dropped courses? Have those courses already been approved? It is customary for the dropped courses to be accompanied by a program revision showing the new courses in the curriculum.

COE RESPONSE: *Dr. Nicola Mason (Interim Chair)*: MUE 502/702 Music Tech Teaching Methods was approved in spring 2020 and will replace EME 579/779. These courses were passed with substantial BM and MM curriculum revisions in the spring.

3) The council would like to see a revised syllabus for the ESE 550/750 course. A couple reasons for this request: 1) we have been told that the Professional Growth and Effectiveness System (PGES) is no longer applicable – it is referenced a few times in the syllabus and 2) The syllabus does not contain the updated syllabus statements for AY 2020/2021 available at: https://academicaffairs.eku.edu/syllabi

COE RESPONSE: *Dr. Nicola Mason (Interim Chair)*: An updated syllabus was provided by Dr. Mason. It has been uploaded on the Graduate Council Blackboard site with the following path:

Meetings → 2020-2021 Graduate Council Meetings → September 2020 → Curriculum Proposals

4) Of a greater concern was the statement on the change form: "We are not sure when and how these courses were dropped, but we must have them as cross-listed courses with the math department in order to offer a secondary math program. State reviewers will expect us to have methods courses with education prefixes."

This is problematic for a couple reasons: 1) The program for which the course resides doesn't know why it was removed, 2) It has implications for your state reviewers and 3) MAE (Math Education) is still showing the course as cross listed with their MAE 750 in the new 2020/2021 Graduate Catalog:

• MAE 750 Teaching Mathematics in the Secondary School. (3) I. Cross-listed as ESE 750. Corequisite: CED 840. Developmentally appropriate materials and methods for teaching mathematics and computer science in secondary schools. Credit will not be awarded to students who have credit for ESE 750.

In trying to track this down, I noted that the course does not appear in the 2019/2020 or the 2018/2019 catalog, but was listed in the **2017/2018 catalog**:

• ESE 750 Teaching Mathematics in the Secondary School. (3) I. Cross listed as MAE 750. Prerequisite: admission to the MAT program. Developmentally appropriate materials and methods for teaching mathematics and computer science in secondary schools. Minimum of 96 field/clinical hours. Credit will not be awarded for both ESE 750 and MAE 750.

We are currently going back through CAA paperwork for mentions of MAE 550/750 or ESE 550/750. However, if you have any additional context to help guide our search, that would be helpful. I didn't want to hold up this email and other action items while we searched. If you can provide the requested information by Thursday (17 SEP) Close of Business we can move forward with the consideration of items for next Friday's Graduate Council meeting.

COE RESPONSE: *Dr. Faye Deters (Associate Dean)*: *Email received 16 September 2020 – 3:16 PM*: *Direct quotation except for two clarifications in parenthesis.*

"I do not believe we (COE) put paperwork through to suspend ESE 550/750. I suspect that what may have happened is the process that is used for the courses that have not been taught for five years. In the past, we were sent a list of courses that had not been taught in five years and were subsequently in danger of being dropped. We were allowed to indicate which courses should be kept. We have not been sent such a list for several years now, but it could be that since the course was being offered as an MAE rather than an ESE, the ESE was on the list of courses not taught in five years. I had indicated to Ginni (Dr. Ginni Fair – former Department Chair) that there was a need to alternate the prefix on the cross-listed courses or to offer them both together in order to prevent one version from appearing on that list. I do not know if she reinstituted that practice, but I do think that is likely what happened in this case."
