



- Dr. Trish Issacs, Associate Dean of the College of Business and Technology and Director of the MBA program, was welcomed to the meeting.
- In her introductory comments, Dr. Issacs noted that the ACC 521/721 changes were made based on previous graduate school recommendations.
- The remainder of the courses/items, they relate to an online MBA that is a different curriculum than our existing face-to-face MBA program. The existing program is a cohort model for face-to-face delivery. Looked for efficiencies with some shared courses between the two. Also relying on colleagues in other colleges for the concentration.



- There are a total of 21 business courses in this online program MBA prefixes functional areas of business and a capstone. The strength of the program is the flexibility.
- Dean's Council asked about current students, and would they just switch to the online program? Surveys with current students noted that some would switch but a significant number chose the on-campus program for face-to-face instruction.
- SACSCOC has made some changes with immediate effective dates Substantial Change Policy. This policy has gone from an institutional level to a program level.
- QUESTION FROM DR. BURNS: Will the dropped courses on the agenda have any impact on current students?
- ANSWER FROM DR. ISAACS: Yes, there is a replacement course for them. Those are the shared courses.

#### 3. Free Textbooks for Graduate Students Discussion – Dr. Matt Sabin

- Graduate enrollments could greatly benefit from such an initiative and the graduate student population is much smaller and require less financial funding.

- Dr. Slusher asked where the money was coming from to provide the free textbooks for undergraduate students at EKU?
  - Dr. Baggett noted that no tuition increase has been discussed, but he is unaware where the specific funds for the BookSmart funds are being derived. Specifically, this is a collaboration with Barnes and Noble Bookstore.
- Dr. Baggett also provided an update on the new federal stimulus funding coming to EKU as was shared by Dr. McFaddin earlier in the week.
- Dr. Baggett noted that this is a year-by-year deal. Hopefully it will continue past the 21/22 academic year.
- The fact that it doesn't start until the fall semester was also identified by the group.
- Dr. Sabin noted that we want to make encourage administration to provide our graduate students the same benefits and opportunities. Graduate School seems to be overlooked with these initiatives.
- Dr. Howell (OT) noted that the free books are a rental but must give them back or buy them at a reduced rate. Could the conversation around graduate students receiving this benefit could also include the ability to keep them during their graduate courses and turn them in (or buy them) at the end. Many of the textbooks we use serve as references for other courses. We could be strategic about the books that they use in the program.

E: Academic Credit Regulation

#### Executive Summary

A revision of Regulation 4.2.3, Determining the Amount and Level of Academic Credit, is submitted for your consideration. This regulation was first adopted in 1987 as part of the Faculty Handbook. The regulation had not been revised since. This revision updates the regulation by including the federal definition of a rectif hour and by better articulating our practice. Finally, the revision affirms the primary role of faculty in determining the amount and level of academic credit.

The regulation has been approved by the Council on Academic Affairs, the Chairs Association, the Faculty Senate, and the Provost Council. The regulation also was posted for 30 days and garnered 1 comment that resulted in a minor edit. In light of the support given by the campus community, Regulation 4.2.3 is therefore submitted for your consideration. 

#### **Graduate Student Learning Outcomes**

The Graduate School has adopted a core set of Graduate Student Learning Outcomes common to all graduate programs offered at EKU. While individual courses might not incorporate all of these, programs are expected to demonstrate that they are contained in a graduate student's program of study.

When students graduate from EKU Graduate Programs, they will be informed, critical and creative thinkers who communicate effectively.

*Informed* thinkers demonstrate mastery of the significant ideas of, and skills and abilities demanded by, their discipline.
